1. A temporary food permit or other food service license must be obtained from the Eaton County Health Department at 528 Beech Street, Charlotte, Michigan, 48813, A Health Department inspection will be made and violations will cause a shutdown of the facility involved.

3. There will be no overnight parking in the Arts and Crafts area or in the downtown parking lots. If this rule is violated you will be asked to leave the event and will not be allowed to return to future

shows.

**PARKING**

No parking will be allowed in the city parking lots. Any exhibitor who parks in the city lots will be asked to leave and will not be allowed to return to future festivals.
